APPLICATION FOR RECONSTRUCTION / REPAIR OF PREVIOUSLY-PERMITTED COASTAL STRUCTURES

Previously licenced/permitted coastal structures that are damaged by storms can be rebuilt without the issuance of a new coastal works permit, provided the following conditions are met:

- The Applicant must submit a “Reconstruction/Repair of Previously-Permitted Coastal Structures” application form to the Ministry of Environment.
- The structure must be rebuilt to the same dimensions previously approved in the Licence/Permit.
- The approved location, footprint and plan area of the coastal structure must remain unchanged.
- Reconstruction Work must be in accordance with the conditions set in the original Licence/Permit.
- The Applicant receives the Coastal Works Approval from the Ministry of Environment advising that reconstruction of the structure can commence.
- Notification to the Department of Environment (DOE) of the commencement date of works and subsequent receipt of Coastal Works Notices issued by the DOE.

N.B. Currently there are **no** additional fees for reconstruction/repair of previously-permitted structures that meet the above criteria. DOE Conservation Officers **will** be inspecting reconstruction sites to ensure that the Applicant is complying with conditions specified in their approved Coastal Works Permit. Unauthorised structures may be ordered to be removed and/or be subject to prosecution under the National Conservation Law (2013).

The above policy will apply to all coastal structures in public canals, such as Governor’s Harbour and Lime Tree Bay, SafeHaven, and Snug Harbour (Hyatt canal). Coastal structures situated in private canals will require authorisation from the Central Planning Authority.

Applicants wishing to construct a new coastal structure, rebuild a coastal structure that predates the current coastal works application process (i.e. does not have a coastal works licence/permit), or rebuild in a manner that does not comply with the above conditions will be required to submit a new coastal works application. Unauthorised structures may be ordered to be removed and/or subject to prosecution under the National Conservation Law.

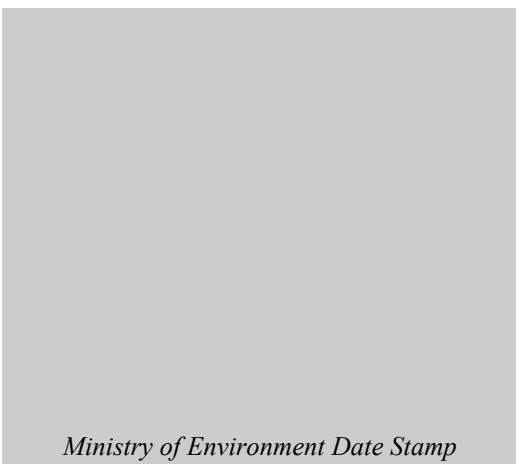
